#### Visa

Incoming students must bring a valid passport and either a study visa ("X1") [for students studying for more than 6 months] or a visiting visa ("X2") [for students studying for less than 6 months]. The visa application form can be downloaded via <a href="https://studyinchina.edu.cn/">https://studyinchina.edu.cn/</a> after students receive their acceptance letter. Law School exchange students should apply the X2 visa to Chinese Embassy in their home country with the Acceptance Letter, visa application form and other materials as required by the Chinese Embassy. Other visa types will not be allowed to register at PKU.

\* The visa falls within the mandates of Chinese diplomatic authority. Any information related to visa application in this document can only be informative instead of legally binding. Please consult with the Embassy should you have any questions.
