The Searle Center on Law, Regulation, and Economic Growth is issuing a call for proposals for young scholars to attend the invitation only **Third Annual Research Roundtable on Innovation Economics: Patents and Technology Standards Data Sets**. The conference will be held at the Northwestern University School of Law in Chicago, IL. The conference will run from approximately 12:00 P.M. on Thursday, April 9 2015 to 3:00 P.M. on Friday, April 10, 2015.

The roundtable is organized by Daniel F. Spulber and Stuart Graham.

The conference introduces major new data sets from the USPTO, the Census Bureau, Berkeley Engineering, the Searle Center Innovation Economics Project, and others. The roundtable will feature a series of presentations that will focus on the cutting-edge databases that are currently being created in this area. The roundtable is to provide a forum where economists and legal scholars can gather together with Northwestern's own distinguished faculty to present and discuss high-quality research relevant to intellectual property (IP) protection, innovation, and technology standards.

Attendance for this roundtable is by invitation only. A limited number of invitations will be issued to academics and PhD candidates who are starting work in this area of empirical research. Those who are interested in receiving an invitation to the roundtable should submit a brief proposal consisting of a bio and a short abstract of your research interest in this area. This should be in the text of an email and sent to the Searle Center at [searlecenter@law.northwestern.edu](mailto:searlecenter@law.northwestern.edu).

Invited attendees will receive a participant fee of \$1,000.00 and must plan to attend and interact for the full duration of the roundtable. If preferred, the Searle Center can instead reimburse confirmed participants for reasonable travel expenses up to \$1,000.00. The Searle Center will also reserve and pay for hotel accommodations for authors and discussants for the night of Thursday, April 9, 2015. For those individuals who are travelling from the West Coast or from overseas, we will also cover hotel accommodations for the night of Wednesday, April 8, 2015 as well.

**Submission Deadline:** Applications to attend the roundtable should be submitted to [searlecenter@law.northwestern.edu](mailto:searlecenter@law.northwestern.edu) no later than **February 1, 2015**. Applications will be considered on a rolling basis until that date.
